

# Fishbowl Area Use Agreement

This agreement is between **Phillips Community Pool** and \_\_\_\_\_ (Host/Responsible Adult) for hosting a birthday party at the pool and using the *Fishbowl Area* for food, presents, etc.

## 1. Party Information

## 2. Fees, Deposits, and Cancellations

- A **\$40.00 total fee** is required **upfront** when this agreement is signed.
  - Of this amount:
    - **\$20.00 is a non-refundable facility use fee**
    - **\$20.00 is a refundable cleaning and compliance deposit**
  - **The party date is not reserved until the full \$40.00 payment is received.**
  - **Cancellations must be made at least 24 hours in advance** to receive a refund of the \$40.00 payment. Cancellations with less than 24 hours' notice will forfeit the full payment.
  - The **\$20.00 refundable deposit** will be returned after the party if all rules are followed and the Fishbowl Area is left clean.

## 3. Fishbowl Area Rules

The Host/Responsible Adult agrees to ensure all guests follow these rules:

- **No wet swimmers are allowed in the Fishbowl Area**
- **Doors may not be propped open**
- Food and drinks must stay in the Fishbowl Area
- No running, rough play, or unsafe behavior
- Children must be supervised at all times

---

## 4. Cleanup Responsibilities

Before leaving, the Host/Responsible Adult must ensure:

- All trash is placed in trash cans
- Tables and chairs are wiped down and returned to their original setup
- Decorations are removed
- The area is left clean and orderly

Staff will inspect the area after the party to determine if the refundable deposit will be returned.

## 5. Facility Rules

- All pool and facility rules must be followed at all times
- Guests must follow directions given by pool staff
- The Host/Responsible Adult is responsible for the behavior of all guests

Failure to follow facility rules may result in removal from the facility without refund.

---

## 6. Liability Acknowledgment

The Host/Responsible Adult understands that swimming and pool activities involve some risk. By signing this agreement, the Host/Responsible Adult accepts responsibility for themselves and all party guests.

To the fullest extent allowed by law, the Host/Responsible Adult agrees to **release and hold harmless Phillips Community Pool**, its staff, employees, volunteers, and governing bodies from claims related to the birthday party or use of the facility, **except in cases of gross negligence or willful misconduct**.

The Host/Responsible Adult also agrees to make sure all guests follow facility rules and staff instructions.
